


Figure 1: AppBroker Software for BMC and FlexNet Manager Suite work together to bring governance and automation to the application request process



How It Works

An employee, who needs software, visits MyIT to request applications. Through MyIT Service Broker, AppBroker software for BMC first evaluates whether a license is required. When a license is required, AppBroker checks for an available license and reserves it to ensure on-going software license compliance. The request is sent through the MyIT approval process, and once approved, AppBroker Software for BMC directs the appropriate deployment system to deliver the application to the employee's device. During the delivery stage, the status of requests is continually monitored and the MyIT system of record is updated, generating an incident if application delivery is not successful, enabling IT to proactively address any issues.

To further optimize software license consumption and reduce spending on new software licenses, AppBroker enables the automation of software reclamation to uninstall applications that are not used or rarely used. The reclamation of software frees up licenses for reuse and provides data for more informed contract negotiations with software vendors.
