

Evaluation, Free, and NFR Products

The use of Products received by Licensee for purposes of evaluation ("Evaluation Products"), regardless of how labeled, any Product provided at no charge ("Free Products"), and any Product that is identified as a "Not for Resale" or "NFR" license ("NFR Products") will be governed by the terms set forth herein.

- 1. Grant of License. Subject to all of the terms and conditions of this Agreement, Flexera grants Licensee:
 - a. For Evaluation Products: during the Evaluation Period, a limited, internal use, non-exclusive, non-transferable license to use the Product solely to evaluate its suitability for Licensee's internal business requirements at Licensee's site(s) only. Without limiting the foregoing, Licensee may not use the Evaluation Product during the Evaluation Period to (i) create or deploy any application, package, or other software, (ii) manage any production device, (iii) share data or information included in the Evaluation Product, or (iv) for any other purpose not expressly set forth herein. This license may be terminated by Flexera at any time upon notice to Licensee and will automatically terminate, without notice, upon the first to occur of the following: (a) the completion of Licensee's evaluation of the Evaluation Product or (b) the expiration of the Evaluation Period. Except as otherwise expressly set forth herein, the license does not include rights to any source code.
 - b. For Free Products: a limited, internal use, non-exclusive, non-transferable license to use the Product for Licensee's internal business requirements at Licensee's site(s) only. Except as otherwise expressly set forth herein, the license does not include rights to any source code. This license may be terminated by Flexera at any time upon notice to Licensee.
 - c. For NFR Products: a temporary, limited, internal use, non-exclusive, non-transferable license to use NFR Products solely for the purposes of training, education, and support for Licensee's internal personnel. Without limiting the foregoing, Licensee may not use NFR Products to (i) create or deploy any application, package, or other software, (ii) manage any production device, (iii) share data or information included in the Evaluation Product, or (iv) for any other purpose not expressly set forth herein.
- 2. **Evaluation Period**. If Licensee has received the Product for purposes of evaluation, regardless of how labeled, the use of the Product is limited to a specified period of time, as detailed in the email accompanying the download instructions, or if not specified in such email or if no such email is received, twenty one (21) days from Licensee's acceptance of the Agreement or first use of the Evaluation Product, whichever is earlier (the "Evaluation Period).
- 3. **Limited Use**. Portions of the full-use version of the Products may be withheld or unusable. Full use of the Products may be restricted by technological protections. Flexera may impose any other limitations on use of the Products in its sole discretion.
- 4. No Support. Flexera will have no Support obligation to Licensee for unless otherwise agreed by the parties.
- 5. DISCLAIMER OF WARRANTY. EVALUATION PRODUCTS, FREE PRODUCTS, AND NFR PRODUCTS ARE PROVIDED ON AN "AS IS" BASIS. NEITHER FLEXERA NOR ITS SUPPLIERS MAKE ANY WARRANTIES, EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY, TITLE, FITNESS FOR A PARTICULAR PURPOSE OR NONINFRINGEMENT. LICENSEE MAY HAVE OTHER STATUTORY RIGHTS. HOWEVER, TO THE FULL EXTENT PERMITTED BY LAW, THE DURATION OF STATUTORILY REQUIRED WARRANTIES, IF ANY, WILL BE LIMITED TO THE SHORTER OF (I) THE STATUTORILY REQUIRED PERIOD OR (II) THIRTY (30) DAYS FROM LICENSEE'S ACCEPTANCE OF THE AGREEMENT.

IN NO EVENT WILL FLEXERA BE LIABLE FOR ANY DAMAGES, INCLUDING LOST PROFITS OR DATA, OR INCIDENTAL OR CONSEQUENTIAL DAMAGES, ARISING OUT OF THE USE OR INABILITY TO USE THE PRODUCTS OR ANY DATA SUPPLIED THEREWITH, EVEN IF FLEXERA HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, OR FOR ANY CLAIM BY ANY OTHER PARTY. IN NO CASE WILL FLEXERA'S LIABILITY FOR ANY DAMAGES HEREUNDER EXCEED FIFTY DOLLARS (US \$50).
- 7. Termination. Licensee's license to Evaluation Products, Free Products, and/or NFR Products may be terminated by Flexera at any time immediately upon notice to Licensee. In the event of termination, Licensee must cease using the applicable Products, destroy all copies of the Products (including copies in storage media), if applicable, and certify such destruction to Flexera. This requirement applies to all copies in any form, partial or complete. Upon the effective date of any termination, Licensee relinquishes all rights granted under this Agreement.
- 8. **Software, SaaS, and Content.** For the purpose of the Agreement, Evaluation Products, Free Products, and NFR Products may include any of the following: "Software", "SaaS", and "Content".
